# 4. CHC Programs & Updates/ Quality- Flu Vaccine and Screening Reminder

TK Dana, Manager of Quality Management provided updates on the flu vaccine and breast cancer screening reminders.

- Flu Shot
  - CHC recommends everyone over the age of 6 months receive the vaccine as well as speaking to your physician to make sure it is right for you.
  - Vaccines can be found your doctor's office or pharmacy.
- Breast Cancer
  - o Breast cancer is the most common cancer in women.
  - CDC recommends if you are ages of 40-49 talk to doctor about when you should receive screening and if you are ages 50-74 CDC recommend screenings mammogram every two years.
  - If a participant has disabilities or if a screening may be challenging- TK recommended scheduling know you have specific needs. Talk with your doctor about your concerns.

Anne Dodd, Health Equity & Quality Analyst presented the 2022 Program Evaluation everyone has a fair and just opportunity to be as healthy as possible and each individual experiences the world differently, requiring support in different ways.

- HECLAS Health Equity Culturally and Linguistically Appropriate Services program establishes a planned approach to promote culturally responsive care and services to improve the following:
  - Health Care Disparities
  - Provider of Network Cultural Responsiveness
  - o Community Involvement
  - o Assessment of Language Services
- HEDIS Performance Measures by Race, Ethnicity, and Language (REL)
  - ACP CHC uses Healthcare Effectiveness Data and Information Set (HEDIS) to evaluate health measures by Race, Ethnicity, Language and Gender to determine if disparities between populations exist.
  - Different cultural groups may experience difficulty receiving services because of their ethnic customs, comprehending the need for services, or may not know certain benefits exists.
  - The measures reviewed are Controlling Blood Pressure, Diabetes measures and Adults' Access to Preventive/Ambulatory Health Services.
  - Interventions are developed to address needs from the information collected the previous year and analyze the impact.

A PAC Member who utilizes both agency and self-directed models asked, "Is there have many requests for sign language?" Ann Dodd replied "Yes, and there are also services for the blind to transcribe "materials in braille." PAC Member then asked, "What if there is an emergency?"
